- Position:** Research and Evaluation Graduate Student Internship,
National Center for Educational Achievement (NCEA)
- Location:** Austin, Texas
- Minimum Qualifications:** We seek students who meet the following criteria:
- Enrolled in a masters or doctoral program and have completed the equivalent of one full year of graduate level coursework;
 - Have already been exposed to research methods and substantive issues in their field of expertise;
 - **Knowledge of curriculum and instructional practices in secondary and elementary schools;**
 - Have excellent oral and written communication skills;
 - Are eligible to work in the United States; and
 - Have support from his/her academic advisor.
- Essential Job Functions:** Students will work a minimum of 2-3 days per week (or ~20 hours per week) at the National Center for Educational Achievement in Austin, Texas, from September 1, 2010 to August 31, 2011. The students may work on a single evaluation project or multiple projects, but all work will include conducting comprehensive literature reviews on current topics in the field of education.
- The goals of the R&E Graduate Student Program are as follows:
1. To enhance graduate students' skills and capacities in educational research and evaluation;
 2. Stimulate evaluation thinking by providing professional development training opportunities for graduate students; and
 3. Deepen the NCEA's capacity to conduct meaningful educational research and evaluation studies in the area of higher performing schools.
- Compensation:** Students will be paid up to \$18.00 per hour depending on experience for the duration of the program. This is not a benefits eligible position.
- Reports To:** Director of Research and Policy, NCEA
- Criteria for Selection:** The students will be selected based on their completed application and subsequent finalist interviews focusing on:
- The alignment between their skills, aspirations, locale, and placement needs;
 - The quality of academic and related experiences as preparation for the program; and
 - The capacity to complete the program assignments and expectations.
